Good news! Beginning Nov. 1 you can **enroll** or **renew** your health insurance coverage for 2021.

Plans include CareFirst, Kaiser Permanente and United Healthcare (**new**).

Plans that work for you and your budget! Nine in 10 who enrolled got financial help to cover the cost of their plan.

All plans include important benefits, like COVID-19 testing and treatment, mental health care, doctor visits and more.

People who are eligible for Medicaid can apply any time of the year.

Adults 18-64 years of age may be eligible.

Trained bi-lingual experts are available to help — **virtually** from your computer or phone.

Get Ready to Enroll! You Will Need:

- » Photo ID
- » Social Security Number
- » Immigration/Citizenship Documents (for some residents)
- » Pay stubs or W-2 wage and tax statement if employed
- » Policy numbers for any other health insurance
