15 Years Serving Montgomery County, Maryland

On July 28, 2023, we celebrated 15 years of service in Montgomery County, Maryland, and the 5th anniversary of our newest clinic in Silver Spring. When we opened our first location in 2008, we witnessed the urgent need for a larger location and additional services. In 2018, we moved to our current building and were able to add new services such as dental in 2020 and sonography in 2023. This steady growth has now tripled our capacity in Montgomery County with more than 58,000 appointments in 2022. Through our collaborations and partnerships, we can offer participants a myriad of resources and services.

Long-COVID Clinic

In 2023 Mary's Center has been supporting participants impacted by the long-term effects of COVID-19 with symptoms lasting several weeks. Studies show one of five people who have contracted COVID-19 experience these long-COVID symptoms, and through our Long-COVID Clinic, our Infectious Disease team is providing comprehensive care and treatment to hundreds of participants experiencing such long-term effects with additional support from our different programs.

Mary's Center Supports Newly Arrived Migrants

Since 1988, Mary's Center has made increasing efforts to aid migrants as they adapt to living in the DC area. In response to the current migrant influx from the border to the DC region, Mary's Center has been active on multiple task forces within the DC Office on Migrant Services and other local organizations, to help address the immediate needs of these migrants and advocate for policy changes and service needs.

Our Pregnant Moms Benefit From Medicaid Expansion in Maryland

Thanks to the Healthy Babies Equity Act, effective July 1, 2023, noncitizen pregnant residents in Maryland of any immigration status now have access to Medicaid coverage. The benefit provides coverage during pregnancy and for four months after the baby is born. This is important for our work as prenatal care is our flagship service and immigrants are our largest population.


Mary's Center and our partner in education, Briya Public Charter School, were both chosen as 2023 Washington Post USA Top Workplaces for the second year in a row.

Dental Services Expansion

Our Innovative Facilitated Telemedicine Program


Long before the pandemic started, Mary's Center began using telehealth methods to reach more of our participants through our Facilitated Telemedicine Program, which couples a virtual provider visit with an in-person visit from a Medical Assistant at the participant's home. This early practice allowed Mary's Center to hit the ground right when COVID-19 impacted the DC region. With amazing advancements in technology and the widespread availability of smartphones, tablets, and computers, telehealth or virtual appointments have become increasingly popular and beneficial for participants


seeking medical support. This year, our Facilitated Telemedicine Program has seen an increase in adherence to treatment plans and health outcomes as we continue to help our participants keep their appointments from the comfort of their homes. While a medical provider speaks with them virtually, our skilled medical assistants go to their homes carrying everything needed to conduct a full screening and diagnostic examination. Over the past year, Mary's Center has served over 3,000 participants via Facilitated Telemedicine.

LIVES TOUCHED IN 2022


In 2022, we served over 65,000 participants.


The data we are required to report to the federal government includes 51,340 individual participants, which translates to 210,765 visits. This does not include social services, education, and other programs.





Ana Alvarez, Mary's Center's Cancer Navigation Coordinator, and former participant of our teen program, arrived in the US in her teenage years from Guatemala, determined to achieve the American dream. Ana's story is part of a New York Times report "Their Mothers Were Teenagers. They Didn't Want That for Themselves" on the decline in teen pregnancies which have been falling steadily since the early 1990s. Mary's Center's teen program teaches healthy choices and provides support in applying to colleges and/or trade schools. Ana credits this program as what prevented her from becoming a teen mom and instead led her on a path of academic success. Ana said, "At Mary's Center, I was able to get connected with the Teen Program, and there I encountered family, friends, and people who inspired me to become someone professional."
